Massage Member is only valid for Relaxing Maintenance Massage, Deep Tissue/Myofascial Release, or Integrative Bodywork.

We will use our best efforts to process all of your payments properly. However, we shall incur no liability if we are unable to completely process any of your payments because of the existence of any of the following circumstances:

1. If through no fault of ours, your payment account does not contain sufficient funds to complete the transaction or the transaction would exceed the credit limit of your credit card, or your payment account or credit card does not otherwise permit the transaction to be executed; or
2. You have not provided us with the correct account information to process your payment accurately; or
3. Circumstances beyond our control, such as fire, flood, or other interference from an outside force, prevent the proper execution of the transaction and we have taken reasonable precautions to avoid those circumstances.

We reserve the right to cancel your membership for any reason in our Policies, or if we cannot process payments.

Your Massage Membership entitles you to one massage of the chosen time length, per month during the term of your membership. Your membership status must be active in order to redeem any membership massage treatments. Your membership services are not transferable to any other person or entity.

Additional One Hour Massage Therapy Sessions are available to members in good standing for HALF PRICE in the same month. Active members also get a 10% discount on all products. Gift Certificates are also available at a discount of \$10 to members in good standing.

For purposes of identification and billing, you agree to provide us with current, accurate, complete and updated information including your name, address, telephone number, and applicable payment data. You agree to notify us promptly of any changes in your membership data.

You have the right to receive a notice of change in the event that we make any change to the terms and conditions of your membership that will vary the amount to be periodically billed to your account specified in the Membership Contract. We will send you a notice of change at the mailing address or E-Mail address of the member listed on their Contract; at least ten days prior to the effective date of such change. Except as expressly provided herein, we may modify our services or the terms and conditions of this Agreement at anytime without notice and such modifications shall be deemed effective immediately upon making such changes. These terms and conditions can also be found on our website.

Membership Cancellation Policy & Procedure

Cancelling Your Appointment:

All clients are required to give 24 hours advance notice of cancellation or rescheduling of any massage session or pay the No-Show Fee. Clients can also find a friend to take their session at the same time and rate, and will not be charged if THEY (client), fill the space. Clients with Active Memberships or Series will be given the option to pay the No-Show/Cancellation Fee or Redeem a Massage as payment.

Cancellation of Membership During the Initial Term:

You may cancel this Agreement during the initial term of your Membership upon the following conditions:

- a) You change your permanent residence/address to a location more than 30 miles from Dynamic Bodyworks, which MUST be accompanied by written proof of relocation (ie. copy of driver's license or utility bill)
- b) Your death, or permanent physical disability.

If the membership account becomes delinquent and is not properly cancelled, this account will be referred to collections after we make attempts to contact you to fix the issue, and buyer agrees to pay all reasonable collections, agency fees, and legal costs incurred.

OTHER PROVISIONS

LATE CHARGE: If all or part of any scheduled payment is more than 10 days late, we may charge you a late fee of \$10.00.

NOTICE TO CUSTOMER: YOU ARE ENTITLED TO A COPY OF THIS CONTRACT AT THE TIME YOU SIGN IT. YOU MAY CANCEL THIS CONTRACT AT ANY TIME BEFORE MIDNIGHT OF THE THIRD OPERATING DAY AFTER RECEIVING A COPY OF THIS CONTRACT. IF YOU CHOOSE TO CANCEL THIS CONTRACT, YOU MUST EITHER: SEND A SIGNED AND DATED WRITTEN NOTICE OF CANCELLATION BY REGISTERED MAIL, RETURN RECEIPT REQUESTED; OR PERSONALLY DELIVER A SIGNED AND DATED WRITTEN NOTICE OF CANCELLATION TO:
